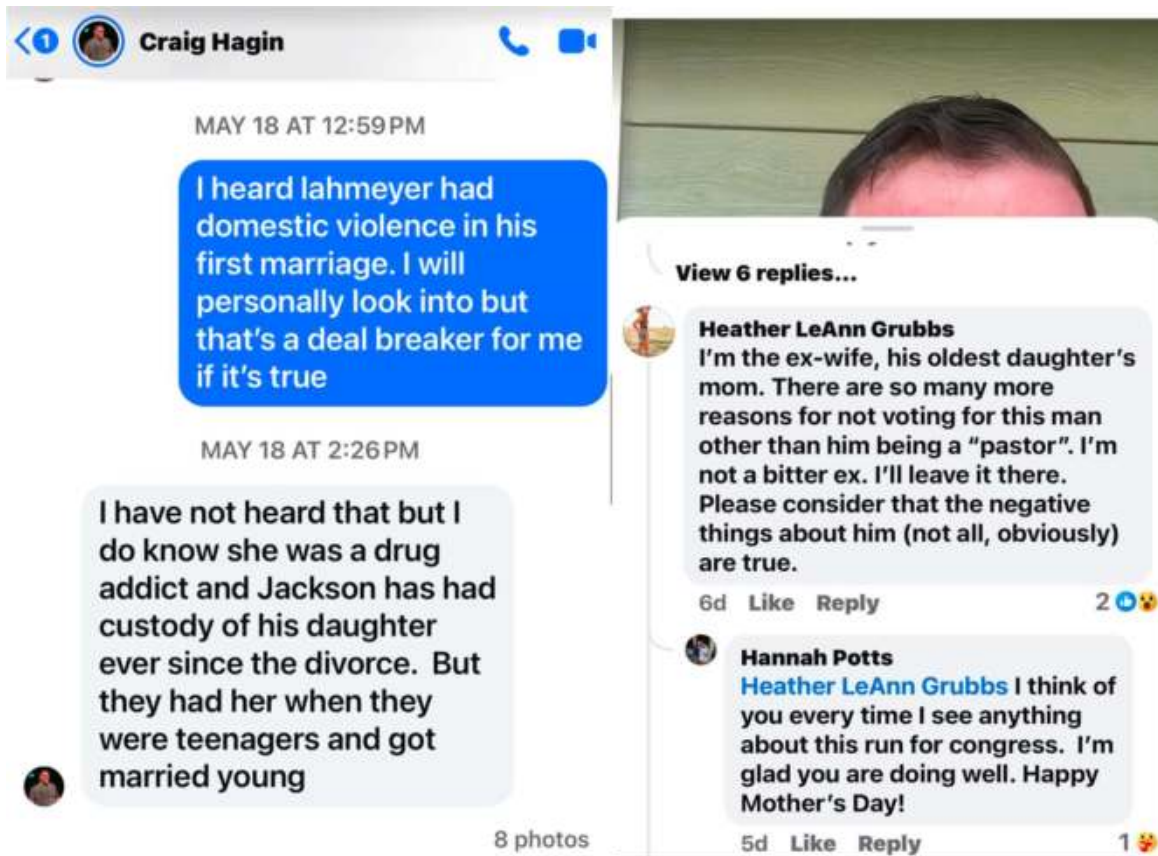

I now know that LOVE WITHOUT RESPECT ISN'T LOVE. I will no longer be anyone's door mat.

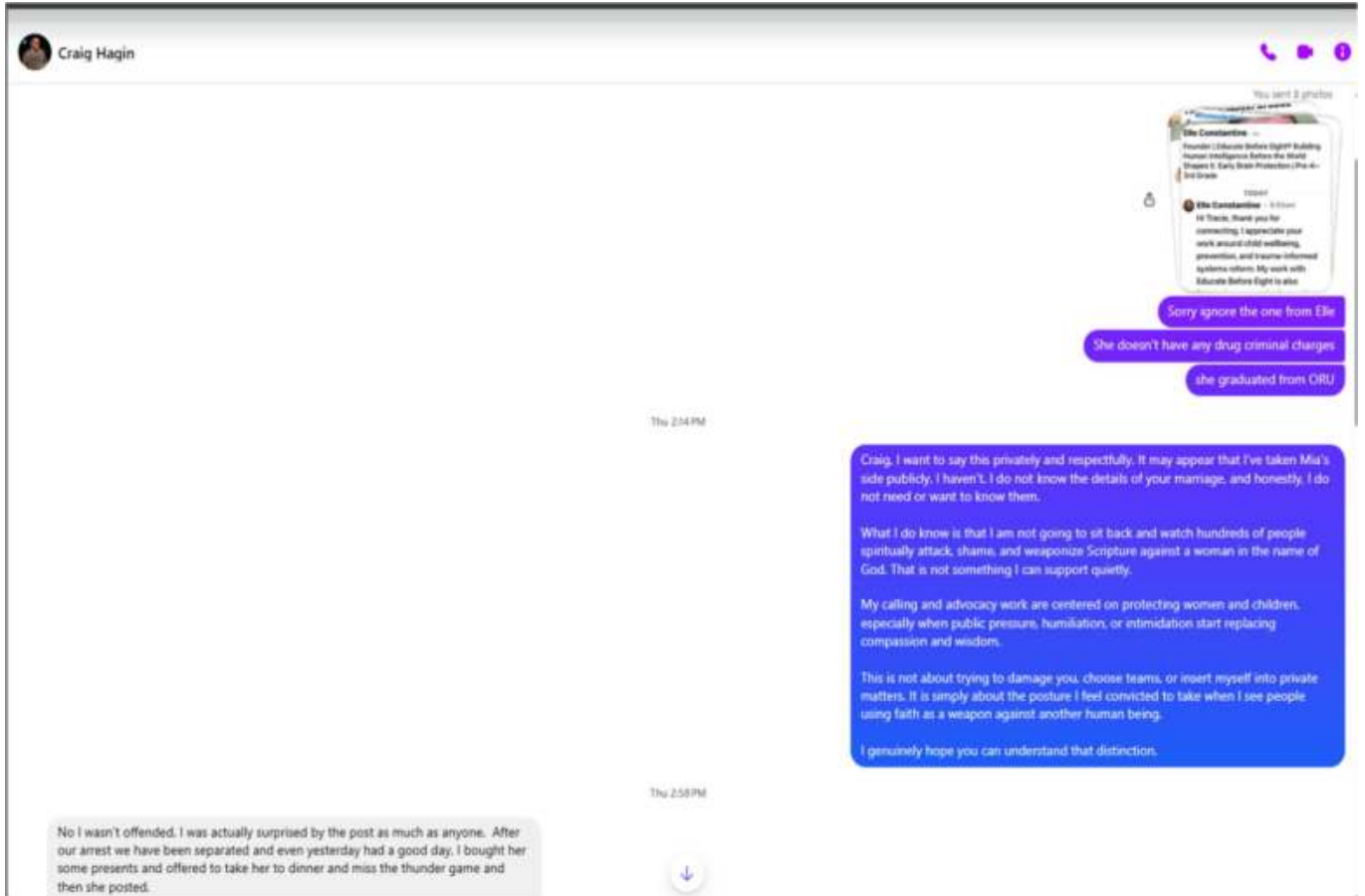
I have given him 20 years to get things right.

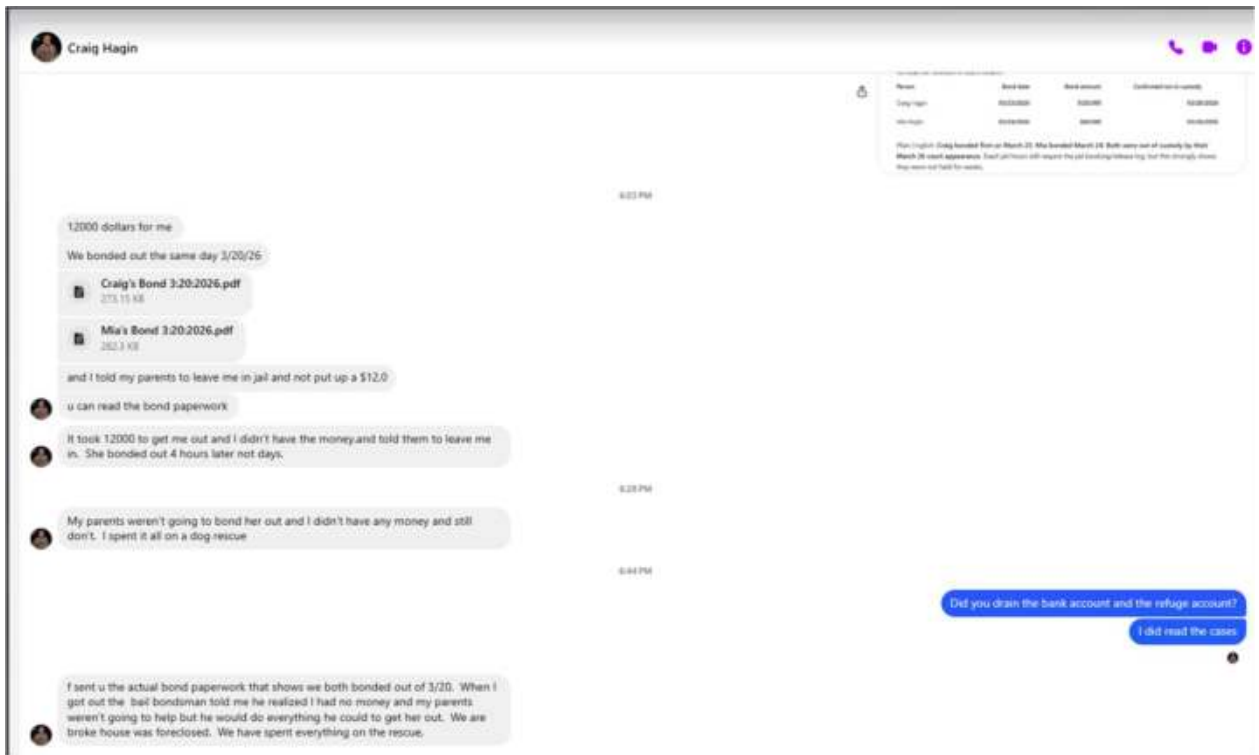
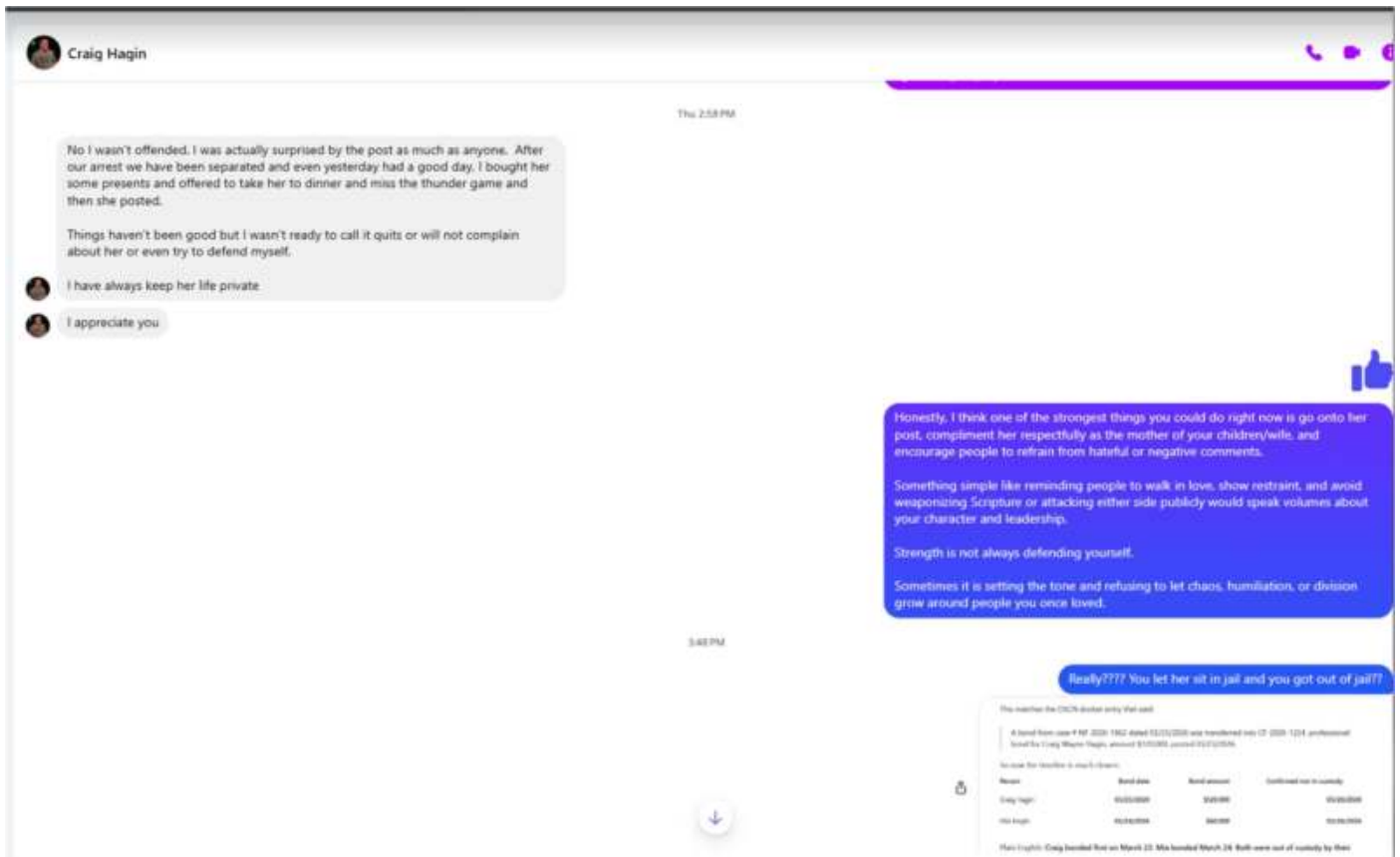
I pray for the Lord to hold my broken heart together As I pack up 20 years of memories in our home and I close our chapter in life.

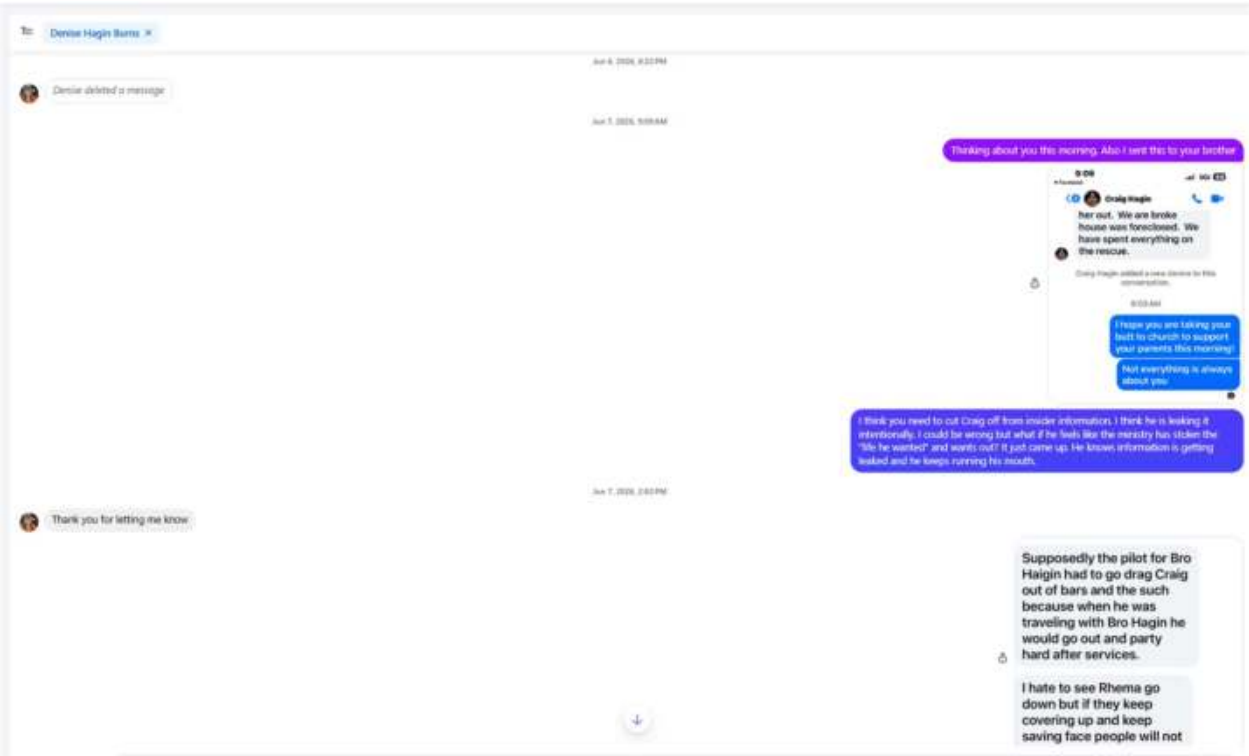
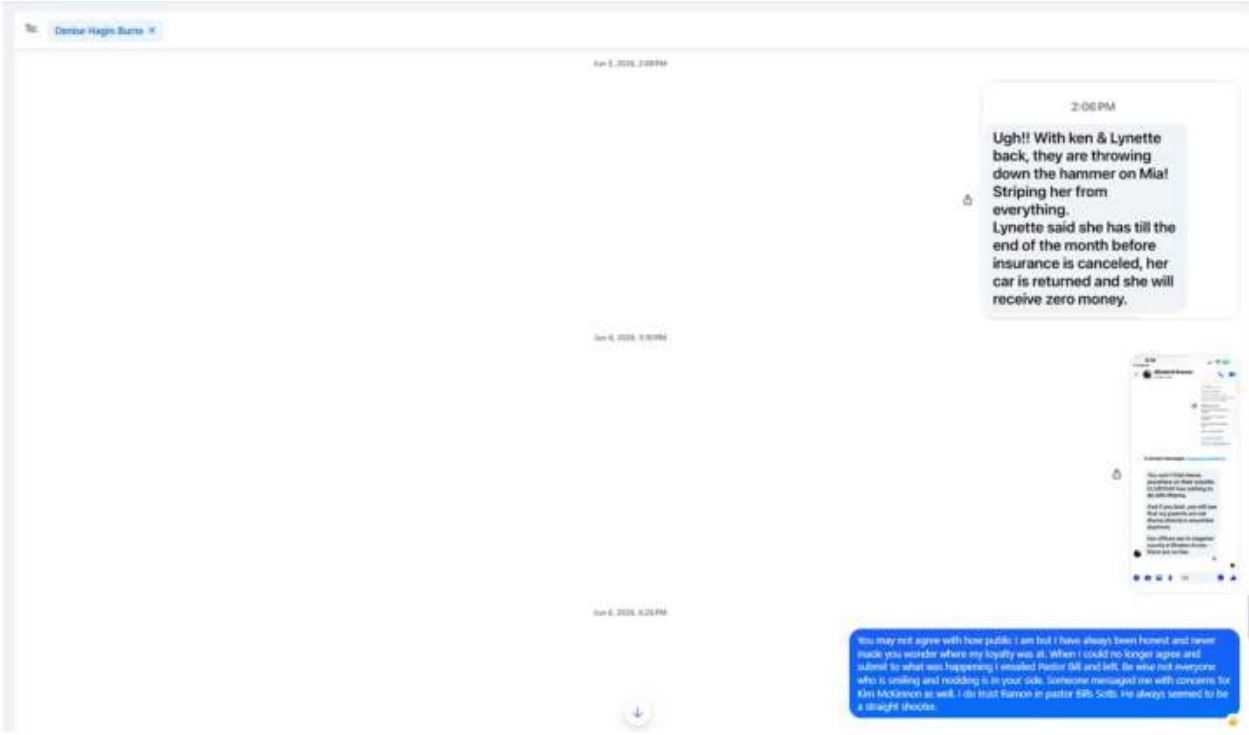
I was just sent this text from Mia on her sister

Letter I wrote to Pastor Bill Ray at Rhema Bible Church after Craig advised me that Pastor Kenneth Hagin and Lynette Hagin bailed him out of jail, refused to bail Mia out of jail and let her sit in jail by herself, unprotected until her children could get together funds for her. Meanwhile, it is being reported Craig Hagin was allegedly making \$500,000.00 a year from the ministry, has 2.5 million in his 401K, and has a property Mia was unaware of until she saw the tax lien.

I sent this to pastor Bill Ray today

I sent this to the Rhema pastor I know the best.

Pastor Bill, I wanted to let you know I have made a decision to stop attending Rhema. When Craig cheated on Missy I stuck, when I called Rhema for help before my divorce and they didn't offer support I stuck, when I got divorced and rather than offering support or calling to ask me how I was they called to ask for my licensing credentials I stuck. When my girls got kicked out of Rhema I disagreed because I knew what their journey had been but I stuck. When the grandkids got into trouble I stuck. When Mia and Craig got arrested I stuck! After hearing all of the details regarding what was happening between them, and recognizing the theme as someone who lived that journey and then seeing that Mia was left in Jail and Craig was bonded out I can't stick. Mia's safety should have come before Craig's as the weaker and more vulnerable person. People have called me to explain that the Hagins and Mia never got along so why would they bail her out, or Mia had her issues to. I don't care. When you are in leadership you are held to a higher standard. This was more than I could overlook. I have seen people seriously hurt or mentally damaged forever by going to jail.

This has literally broken my heart once again. The shhhh ministry keeps people and generations trapped and I won't be a part of it.

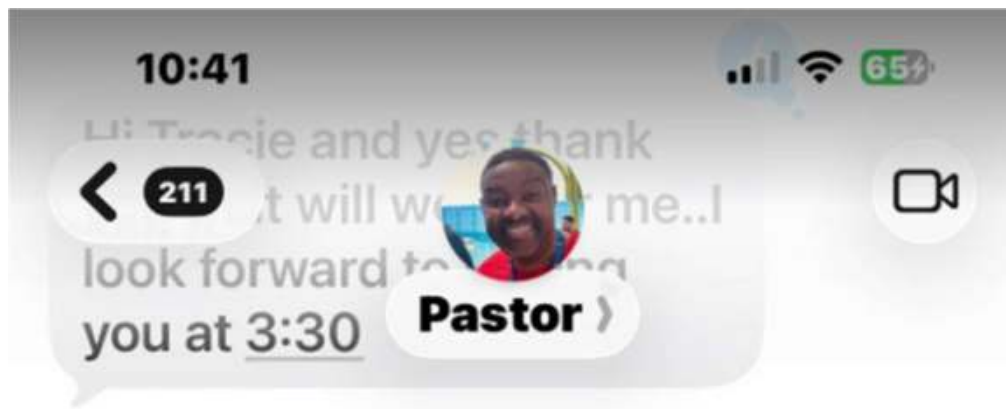
(Backstory for context: I am a 2003 Rhema Graduate with former RMAI credentials, I was an current active member of the church at the time. In this text I am referring to Craigs first marriage with Missy where it was reported that he cheated on her, my first marriage ended after 26 years with him being convicted of two felonies and I was granted a 5 year protective order against him, My daughter 18 at the time was kicked out of Rhema for missing too many days but her tuition was not refunded, when I stated **grandkids I was actually referring to Blake Hagin and the drive by shooting arrest.**)

Rhema Pastor Bill Ray's Response to my text



I went in and did a full disclosure with **Pastor Bill and his secretary**. Pastor Bill stated he was unaware of any allegations. Pastor Bill stated that he did not know what I was referring to in the text I originally sent about my family. (Pastor Bill Ray had met with my abusive husband and counseled him telling him a man is not “in the ministry” if he is not getting paid and he needed to get a job.) I remembered that very well. Pastor Bill Ray and his 1st wife Lorena Ray were also our school of the Bible teachers. Pastor Bill stated I was always welcome back and we said goodbye.

After I left the meeting, I sent Pastor Bill Ray a communication letting him know I was SURPRISED he did not remember me.

Pastor you met with my ex husband before our divorce. I was supporting the family and you got on him and told him (paraphrasing) if he didn't get paid he wasn't a pastor and needed to get a job.

Oh ok great thank you :)

I was surprised you didn't remember us. We were in you and your ex wife Lorena's school of the Bible.

Message that a relative of Mia Hagin sent to Pastor Denise Hagin, Executive Pastor at Rhema Bible Church and Craig Ha

[Redacted] Denise:

I know the things coming to light right now are devastating and difficult to process. None of this has been easy for our family either, and it brings me no joy to have private pain become public.

I don't know if you know this but I was the [Redacted] when Craig's boys were all little. They were my patients. I worked for an amazing Christian [Redacted] brought the boys in all the time for immunizations, check ups & when they were sick. We never saw Craig. But, I will always remember the time she came in totally broken. Asking for help, she needed a Christian counselor due to Craig's constant unfaithfulness & sexual addictions. she also let us know that they were getting a divorce. We were all very heart broken for her.

Fast forward... Mia was living with [Redacted] so she had to sleep on the living room sofa. It was a trying emotional scary time. As it was right after her [Redacted] and she had just returned from [Redacted] home where they were getting her counseling for the trauma. I was more than just worried about her...I actually was in fear for her life and emotional wellbeing. One night she told me she was going out with a couple of friends. I was so worried to let her go, but I did. She ran into Craig that night at a Bar/Club on Brookside (after camp meeting, I might add) she came home to tell me. I was a little hesitant #1 why was he at a Bar, #2 I knew his problems with Missy. I kept quiet. they started dating. Sadly on my part.... I was so overwhelmed with worry for her recovering from her rape that I just thought to myself.... This will be good, she can get the help and healing she needed from Rhema. They will cover her in love and healing. I felt I was handing her and all my worries over. But, I was wrong.

For over 20 years, our family has watched [Redacted] endure repeated heartbreak tied to Craig's hidden sexual behaviors and addictions, including affairs, pornography, prostitutes, financial payouts tied to secrecy and manipulation, and other behaviors that were hidden while he continued serving publicly in ministry leadership. These were not isolated incidents or recent discoveries. There is documentation and proof supporting what has now come to light.

Through all of it, my sister remained incredibly faithful to her marriage. She prayed for him constantly, defended him, protected his reputation, and desperately tried to get him help over many years. Even now, if it were solely her decision, I believe she would still be standing beside him hoping for repentance, healing, and restoration.

One of the hardest parts for me personally was watching the painful difference between the public image presented through the church and what was privately happening behind closed doors. It created deep heartbreak and conflict within our own family. There were seasons of distance because we struggled with allowing Craig [Redacted] questioned their faith in church after witnessing Craigs behaviors that were deeply dishonest spiritually and emotionally.

I also want to say clearly: this situation is not truly about dogs or an animal shelter.

I also want to say clearly: this situation is not truly about dogs or an animal shelter. That has simply become the public storyline people can easily discuss. The deeper issues underneath this family devastation have existed for decades, long before Mia ever came into the picture. I still can't fathom how your parents bailed Craig out of jail and left Mia there for days. What husband leaves his wife in jail and gets himself out.

Craig has been living at [REDACTED] Mom's house for FREE for the past year 1/2. My mom has paid for the roof over their heads & food. All while he was making blackmail payments. ❤️

What is especially heartbreaking is that when [REDACTED] begged for help over the years, very little meaningful intervention happened. [REDACTED] told her it was her fault for letting Craig travel alone. Mia begged Craig to go to treatment and get counseling.

Now, instead of surrounding her with protection and support, she has largely been left financially and emotionally devastated while efforts seem focused on protecting reputations and containing exposure.

I stayed silent for many years because I did not want to destroy a family, a ministry, or people's faith. But I have realized silence can sometimes unintentionally enable deception and allow destructive patterns to continue unchecked.

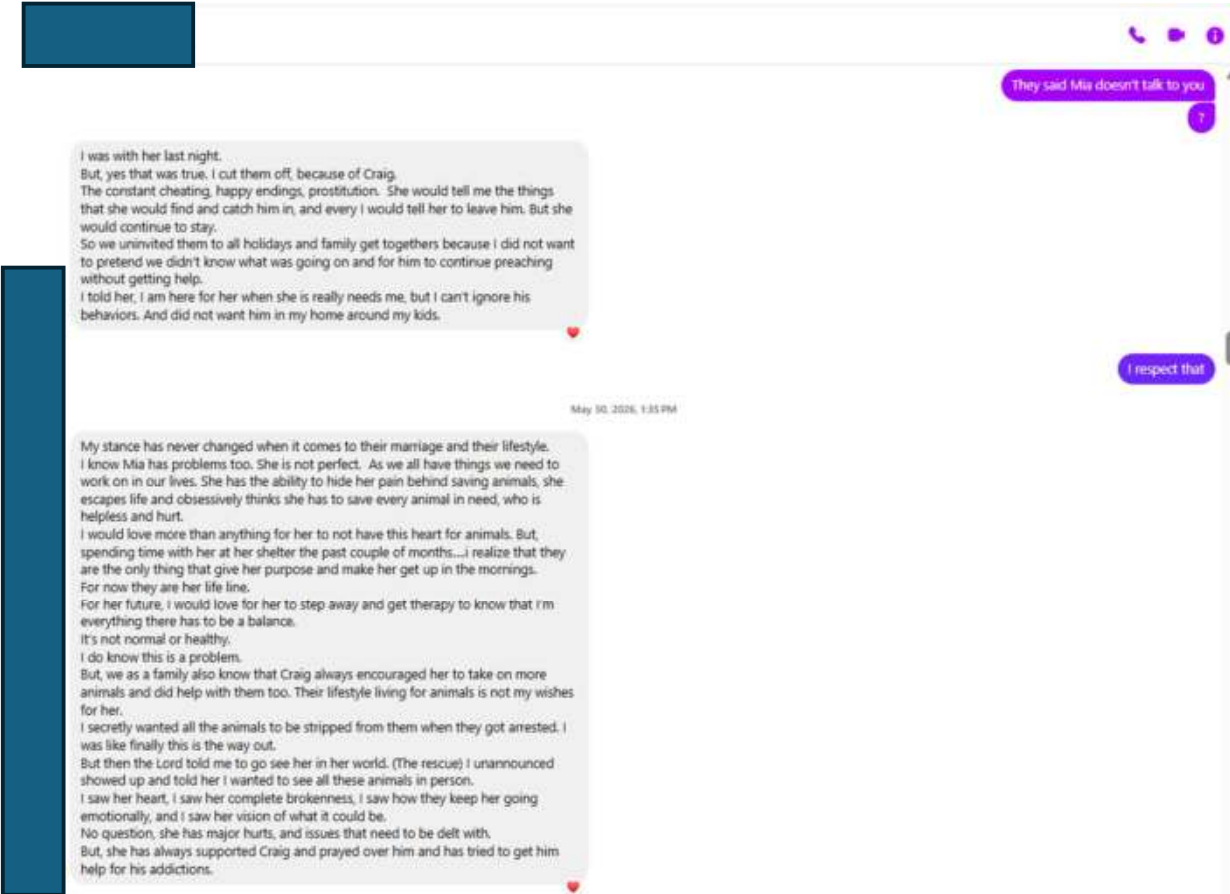
Please continue to pray for Mia. She has lost so much through all of this and needs genuine love, support, stability, and compassion while walking through unimaginable heartbreak.

This entire situation has deeply wounded both of our families, and none of this is being shared out of hatred. It is being shared because the truth can no longer stay hidden.

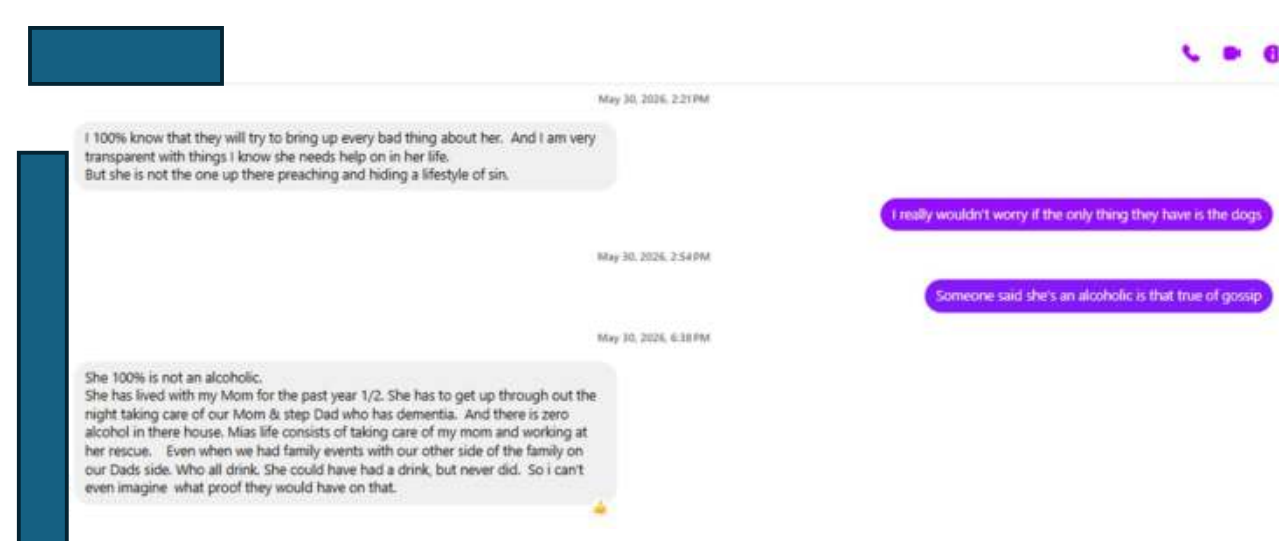

An anonymous Rhema graduate has come forward with a personal witness statement describing what they experienced as a former student and employee.

The testimony raises serious questions about whether standards were enforced equally at Rhema Bible Training College and within leadership circles.

According to this witness, students faced public warnings, threats of expulsion, and intense pressure over behavioral standards. The witness now asks a fair question: why were paying students reportedly held to standards that leadership families were not?

The statement also describes personal interactions with Mia and expresses concern that public support appears focused on protecting reputations rather than showing compassion for the people harmed in the fallout.

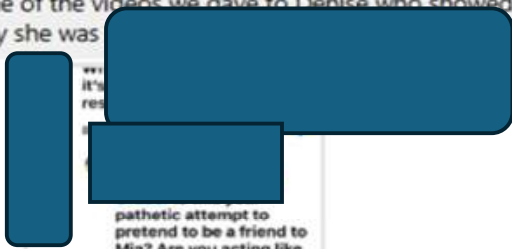

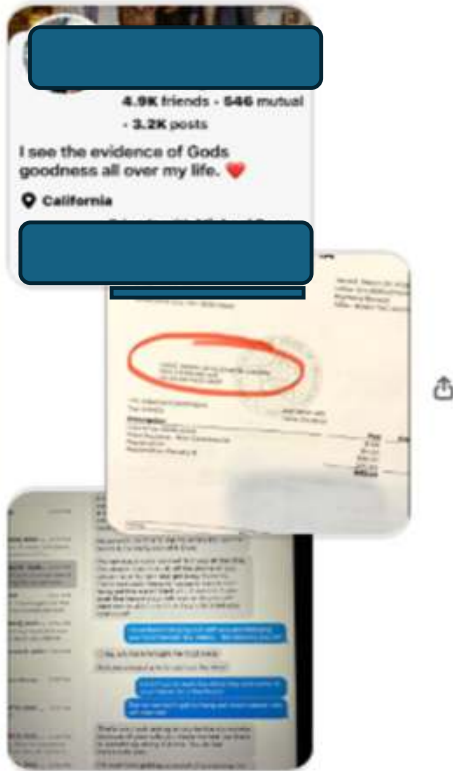

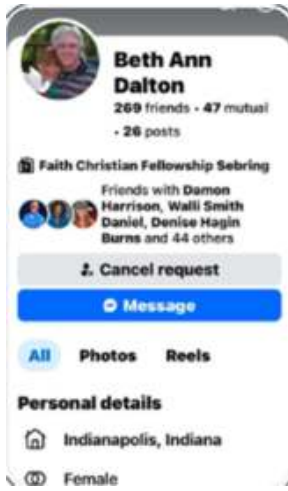

The bigger story may be what happened AFTER concerns were raised.

According to Rhema's own statement:

- Serious concerns had previously been raised.
- Leadership was aware of those concerns.
- Craig was directly confronted.

As a victim advocate, this is where my attention goes.

The statement itself confirms that concerns existed before the documented evidence that resulted in termination.

That raises serious accountability questions.

Who knew?

When did they know?

What action was taken?

What investigation occurred?

Who reviewed the concerns?

Who decided the denials were sufficient?

Who was responsible for protecting the integrity of the ministry?

Who was responsible for protecting those who came forward?

Who signed off on continuing leadership authority after concerns had been raised?

Accountability is not simply firing one person after evidence becomes overwhelming.

Accountability means examining every decision-maker who had authority, responsibility, knowledge, or oversight.

If concerns were reported and ignored, why?

If concerns were investigated, where is the process?

If concerns were documented, who reviewed them?

If concerns involved ministry leadership, what independent oversight existed?

The public is repeatedly told to trust institutions.

Trust is not maintained through statements.

Trust is maintained through transparency.

Trust is maintained through independent review.

Trust is maintained through accountability that reaches every level of authority.

Victims should not have to produce overwhelming evidence before they are taken seriously.

Witnesses should not have to fight organizational loyalty to be heard.

And institutions should not be judged by how they respond after exposure.

They should be judged by how they respond to the first warning sign.

The real question is no longer what Craig Hagin did.

The real question is whether the systems around him functioned as they should have when concerns first emerged.

That is where accountability begins.

And that is where accountability must continue.

OFFICIAL STATEMENT

TO OUR RHEMA FAMILY

We want to speak to you personally, and we want to do so with the same honesty and directness that has always characterized this ministry.

Since our announcement two weeks ago of Craig's termination from the ministry, questions have been raised about what we knew, when we knew it, and why we acted when we did. We want to address those questions as directly and as truthfully as we are able.

When we returned from overseas ministry travel early this month, we were presented with documented evidence of conduct on Craig's part that was wholly inconsistent with the standards we hold for those in ministry leadership, with the values of this organization, and with the son and the leader we believed him to be. As we shared with you two Sundays ago, we reviewed that information fully, and we acted immediately. Craig's employment, leadership roles, and association with Rhema Bible Church and all affiliated Rhema entities were terminated effective June 3, 2021. What we saw was both shocking and devastating, not only as the leaders of this ministry, but as his parents.

We want to be honest with you about something more. This was not the first time that serious questions about Craig's personal conduct had been raised. Craig and Mia came to us privately with issues. We counseled them and were assured by Craig that the issues were resolved. However, continued concerns came to us in the context of the difficulties Craig and Mia were experiencing in their marriage. We heard those concerns. We took them seriously. We went to Craig directly and asked him plainly whether those things were true. He denied them. We believed our son and we now know that in doing so, we were deceived by him.

The documented evidence we received and reviewed upon our return from our international trip, was evidence Denise received a few weeks before our absence. This evidence made it clear that Craig had been living a life we did not see. It was conduct we could not reconcile with the son and the leader we believed him to be, and frankly, conduct we could not imagine he was capable of. He hid this from us. He was living a double life. And in doing so, Craig deceived not only his wife and his family, but also Lynette and me, his sister and brother-in-law, Denise and Don Burns, his ministry, and the people who trusted him.

This caught my attention as it appears that **GRAIG Hagin and Paul Daughtery** (Victory Church Tulsa) both had a protective order requested for a minor child by an adult. It was also interesting that shortly after Craig Hagin's arrest the file on his was ordered to be destroyed.

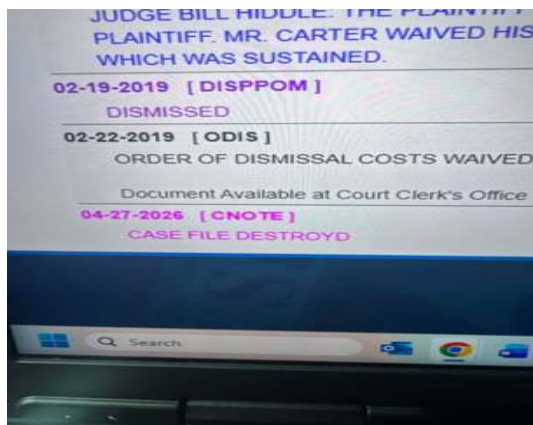



First, you did an excellent job on Resistance Chicks.

I admire your boldness and bravery. I was the anonymous [REDACTED] Alwayslearning, that was responding to you when you first posted information on S. BA about Rhema/Craig. And like many others I want to remain anonymous. I'm a Rhema grad, and many of us have been praying these things would be revealed. I don't have any proof of what I'm going to tell you. But many were aware of it. If what I tell you is true, the Hagins have always known about Craig's issues. Someone may have already shared it. It's been a long time since I was told this, early 2000ish, I believe while Brother Hagin was still alive. I may not remember exact details or I may be remembering them incorrectly. He was married to Missy during this time. A very reliable source told me, that while Craig was the youth pastor, he took his youth group on a mission trip to Mexico. He slept with one of the youth while there. The family of the victim was paid off with hush money. This person told me the Hagins weren't going to remove Craig from ministry. The board forced them to remove him once they found out. If it had happened in the US, he would have been put in jail. I did read a comment somewhere recently that an individual remembers it was announced that Craig was removed from ministry years ago, but Rhema didn't say why. Sounds familiar. His removal could be proven with some investigating. The rumor was this is why his first wife, Missy divorced him. Also, I was told that Pastor Hagin had cheated on Lynette once. Apparently Lynette shared it with a small women's group at church years ago. She apparently said something to the effect of keep your man tired, so he doesn't have the energy to go looking elsewhere. Very reliable source. So if true, it seems it runs in the family. Also Craig sought out prostitutes in Miami while doing ministry. Locally, he went to strip clubs. People that have been around long enough know stuff. Supposedly Craig was making 250,000.00 a year, but everyone knows they pay their people basically nothing. "It's a privilege to serve them." I know several people who were treated VERY poorly while employed at Rhema, basically mentally abused. ALL family members have done this....ALL. They've fired employees without cause or made up a reason...ALL of them. They ALL have tempers. Their tempers eventually come out. You may understand the thinking behind this. I don't. If anyone is succeeding within Rhema/outside of Rhema and becoming more successful than them, they'll cut the off/fire them. One singer had a heart attack at a young age. People say Rhema created so much stress in his life. He was one that was cut off. Or they'll steal an employees ideas and publish a book in their own name. SO many stories. If all the victims came together the whole family would be ostracized and Rhema collapse. Again, I'm emphasizing the whole family. Many of us are quietly applauding you for sharing this. I think anyone who has witnessed the tempers are afraid of the family. Afraid of lawsuits, because that's how they handle things. Protect the ministry, protect the family. Several of us said we think the only reason they dealt with Craig this time is because of social media. They can't hide these things like before. He never should have been returned to the pulpit if Mexico is true or the other rumor that he was cheating on Missy. We all believe they'll eventually return Craig into a ministry position once things quiet down. We'll continue to pray that more be revealed about the family. That they ALL sincerely repent, and changes happen at Rhema. Thank you so much for what you're doing!!!
