Jackson Lahmeyer - Political Record, Public Statements, and Publicly Reported 2026 Controversy

Purpose

This is a source-based research summary of publicly available reporting, campaign materials, and image-source pages. It is not a legal finding, investigative conclusion, or a complete archive of all internet content.

Core accuracy note

The reliable sources reviewed report romantic or intimate text messages and quote Lahmeyer acknowledging that he crossed a boundary through text messaging. They do not establish an admission of a physical sexual affair. Any claim of a physical affair should be attributed to the reporting source and treated as an allegation unless independently substantiated.

Public-source standard

This dossier separates documented statements, media reporting, campaign representations, and contextual links. It does not treat rumors, anonymous claims, or commentary as proven fact.

1. Executive Summary

Jackson Lahmeyer is an Oklahoma pastor and founder of Pastors for Trump who ran in the 2026 Republican primary for Oklahoma's 1st Congressional District. His campaign website presented him as "Pastor. Businessman. America First," promoted support for President Trump, and identified the campaign committee as Lahmeyer for Congress Inc. The site also displayed a Trump endorsement graphic. [Campaign source]

On June 17, 2026, the Associated Press reported that Lahmeyer withdrew from the Republican runoff after media reports concerning romantic text messages with a campaign fundraiser who was not his wife. AP reported that Lahmeyer said in a then-deleted social-media post that he "owned" crossing a boundary line through text messaging. AP also reported that President Trump then endorsed Lahmeyer's runoff opponent, Oklahoma State Representative Mark Tedford. [AP]

The Guardian independently reported that Lahmeyer acknowledged the messages, described the reporting as distorted, said the matter had been handled privately with his wife, and said he ended communication. [The Guardian]

The public record reviewed therefore supports a narrow, careful formulation: Lahmeyer publicly acknowledged crossing a boundary through text messages; major news reports described the messages as romantic or intimate; he suspended his congressional campaign; and Trump shifted support to Mark Tedford. It does not, based on these sources, support stating as established fact that Lahmeyer admitted to a physical sexual affair.

3. 2026 Controversy: What the Public Sources Actually Say

Reported relationship context. Multiple outlets reported that the controversy involved messages between Lahmeyer and a campaign fundraiser, Caitlin Simmons Key, a former Miss Oklahoma USA. The news accounts cited in this dossier are reporting about communications; the dossier does not independently authenticate every message or make findings about private conduct.

Public statement attributed to Lahmeyer. AP reported that Lahmeyer said he “owned” crossing a boundary line through text messaging. The Guardian reported he said the matter had been handled privately with his wife and that communication had ended. [AP] [Guardian]

Political consequence. AP and the Guardian report that Lahmeyer suspended his campaign after advancing to the runoff and after Trump shifted endorsement to Mark Tedford. This is a political fact reported by multiple public outlets.

What should not be overstated. The material reviewed does not itself establish a criminal offense, a physical sexual relationship, coercion, or a broader institutional cover-up. Those are separate factual claims requiring distinct records and corroboration.

4. Political and Organizational Context

Lahmeyer's official campaign website describes his platform in terms of “Oklahoma values” and “America First policies,” promotes support for Trump, and discloses Lahmeyer for Congress Inc. as the paying committee. [Official campaign site]

Axios reported that Lahmeyer founded Pastors for Trump and included him among MAGA-aligned evangelical pastors supporting Trump's 2024 campaign. [Axios]

AP reported that Sheridan Church listed Lahmeyer as part of a Remnant Rising speaker lineup that also included Michael Flynn. That listing documents a scheduled-event association; it does not establish that any speaker knew about or participated in the controversy. [AP]

Craig W. Hagin is included in this dossier only as Rhema leadership context. Rhema's own author biography identifies him as an associate pastor of Rhema Bible Church, instructor at Rhema Bible Training College, and chief operating officer of Kenneth Hagin Ministries. This document does not claim that his public profile establishes involvement in Lahmeyer's campaign or the controversy. [Rhema author bio]

A former Miss Oklahoma USA is speaking out about the sexual misconduct allegations against Presidential Candidate Donald Trump.

She said she doesn't believe them.

Caitlin Simmons Key was Miss Oklahoma USA 2007 and then went on to compete in Miss USA, which is where she said she first met Trump.

Key remembers her pageant days like they were yesterday.

“It was amazing, I had not planned on entering the pageant system, I had been an athlete for 15 years but when the opportunity came I took it, and I’m so glad that I did,” she said.

Key said during her days competing in Miss USA she encountered Trump, who owned the franchise, several times.

So, she said when she heard allegations of inappropriate behavior backstage, she had to speak up.

“You have chaperones that are with you 24/7, and then backstage the only time he came back there was the night of finals with Melania and a group of other people just to congratulate us and wish us good luck, and it was not the dressing room, it was backstage,” Key said.

Key said, in that instance, the women were warned ahead of time that Trump would be coming backstage.

She posted her thoughts to Facebook, where it was shared by dozens of her friends.

Key said she and other Miss USA state title holders have been contacted by national news organizations, but the conversations all ended quickly.

“When we start to give our feedback that is positive, they are done with the conversation, and they are no longer interested in talking to us,” she said.

Key said she is a registered Republican and a Trump supporter, but said friends within the organization who are not, don’t believe the accusations against him either.

Some even signed a letter addressed to media outlets.

Erin: “Do you think that these women that are coming out are lying?”

Key: “I think that everyone has a story to tell and whether or not I believe them is another thing...I think some specific allegations are false.”

Oklahoma's Attorney General has charged a 50-year-old Tulsa businessman with two counts of securities fraud.

Robert Eugene Tucker is currently serving a 10-year suspended sentence after pleading guilty last year to practices similar to the charges filed Wednesday.

In the 2014 case, Tucker was also ordered to pay \$37,500 in restitution to victims and perform 500 hours of community service hours.

In a news release, Attorney General Mike Hunter began an investigation after a complaint was referred his office by the Oklahoma Department of Securities.

In this latest complaint, Hunter states it is alleged a Tulsa resident attempted to invest in Robert Tucker's company, Corporate eXchange International.

During their investigation, agents with the AG's Consumer Protection Unit determined Tucker targeted a victim and sold a six-month note for \$15,000, promising a return of \$17,107.19.

In the release, the Attorney General's office said when the note was due, the victim made several attempts to contact Tucker, who gave multiple excuses as to why he could not pay. Mike Hunter states, eventually, all attempts to contact Robert Tucker were unsuccessful.

The Attorney General's office says in 2011, Tucker also entered into a Consent Judgment with the Oklahoma Department of Securities, which stopped him from selling securities in the state.

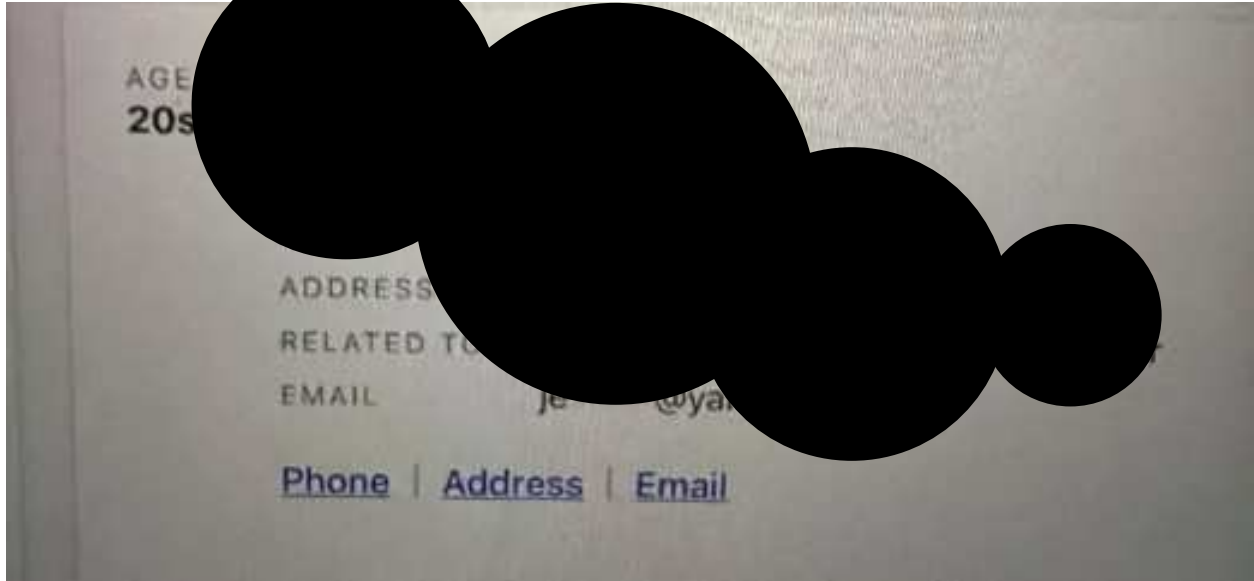



Comes now the Plaintiff, SERVIS ONE, INC. DBA BSI FINANCIAL SERVICES, and for its cause of action against the Defendants above named, alleges and states:

1. That the Plaintiff was all times hereinafter mentioned, and now is duly organized, existing and authorized to bring this action.
2. That the Defendants, Craig W Hagin and Mia M Hagin, were married at all relevant times.
3. That the original maker(s) for a good and valuable consideration, made, executed and delivered to the Payee, a certain written promissory note; a true copy of said note and endorsements thereon, if any, is hereto attached, marked Exhibit "A", and made a part hereof by reference.
4. That as a part of the same transaction and to secure the payment of the note above described and the indebtedness represented thereby, the owners of the real estate hereinafter described, made, executed and delivered to the Payee of the note, a certain real estate mortgage in writing encumbering the following real property, to -wit:

5. 

4. BORROWER'S RIGHT TO PREPAY

I have the right to make payments of Principal at any time before they are due. A payment of Principal only is known as a "Prepayment." When I make a Prepayment, I will tell the Note Holder in writing that I am doing so. I may not designate a payment as a Prepayment if I have not made all the monthly payments due under the Note.

I may make a full Prepayment or partial Prepayments without paying a Prepayment charge. The Note Holder will use my Prepayments to reduce the amount of Principal that I owe under this Note. and (b) any sums already collected from me which exceeded permitted limits will be refunded to me. The Note Holder may choose to make this refund by reducing the Principal I owe under this Note or by making a direct payment to me. If a refund reduces Principal, the reduction will be treated as a partial Prepayment.

6. BORROWER'S FAILURE TO PAY AS REQUIRED

(A) Late Charge for Overdue Payments

If the Note Holder has not received the full amount of any monthly payment by the end of 15 calendar days after the date it is due, I will pay a late charge to the Note Holder. The amount of the charge will be 5.000 % of my overdue payment of principal and interest. I will pay this late charge promptly but only once on each late payment.

(B) Default

If I do not pay the full amount of each monthly payment on the date it is due, I will be in default.

(C) Notice of Default

If I am in default, the Note Holder may send me a written notice telling me that if I do not pay the overdue amount by a certain date, the Note Holder may require me to pay immediately the full amount of Principal which has not been paid and all the interest that I owe on that amount. That date must be at least 30 days after the date on which the notice is mailed to me or delivered by other means.

(D) No Waiver By Note Holder

Any notice that must be given to the Note Holder under this Note will be given by delivering it or by mailing it by first class mail to the Note Holder at the address stated in Section 3(A) above or at a different address if I am given a notice of that different address.

If more than one person signs this Note, each person is fully and personally obligated to keep all of the promises made in this Note, including the promise to pay the full amount owed. 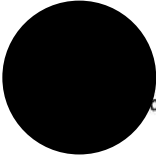

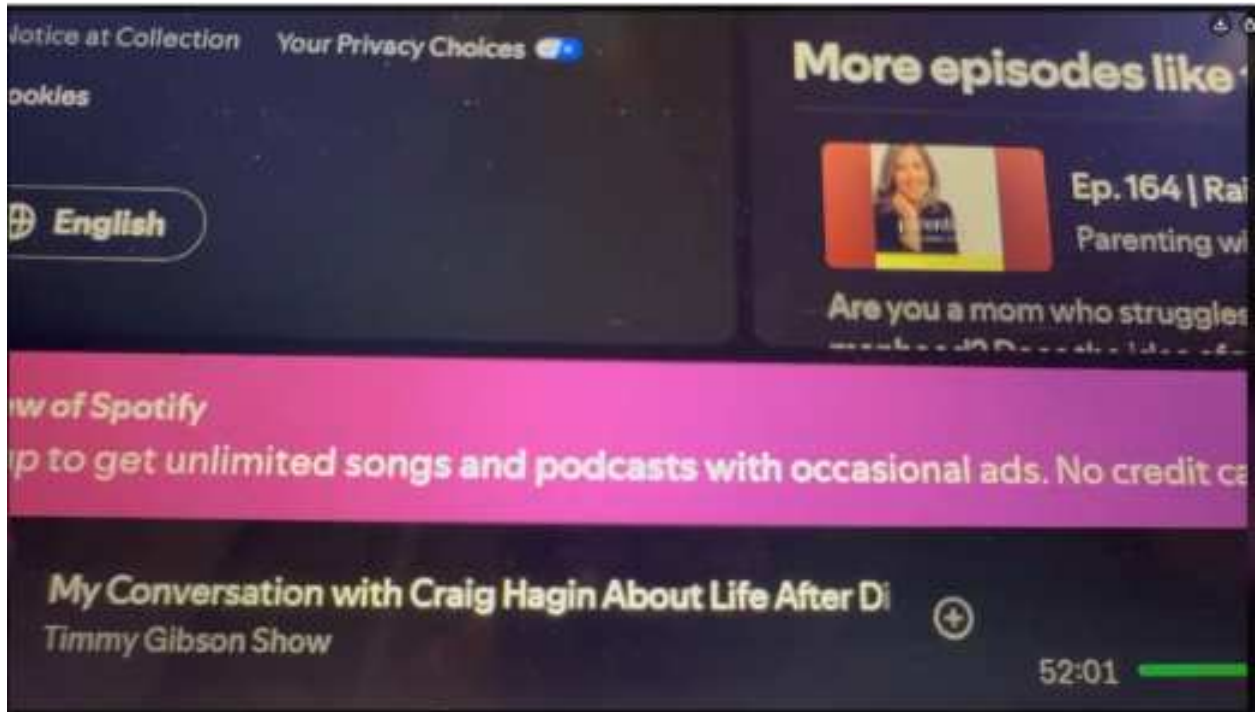

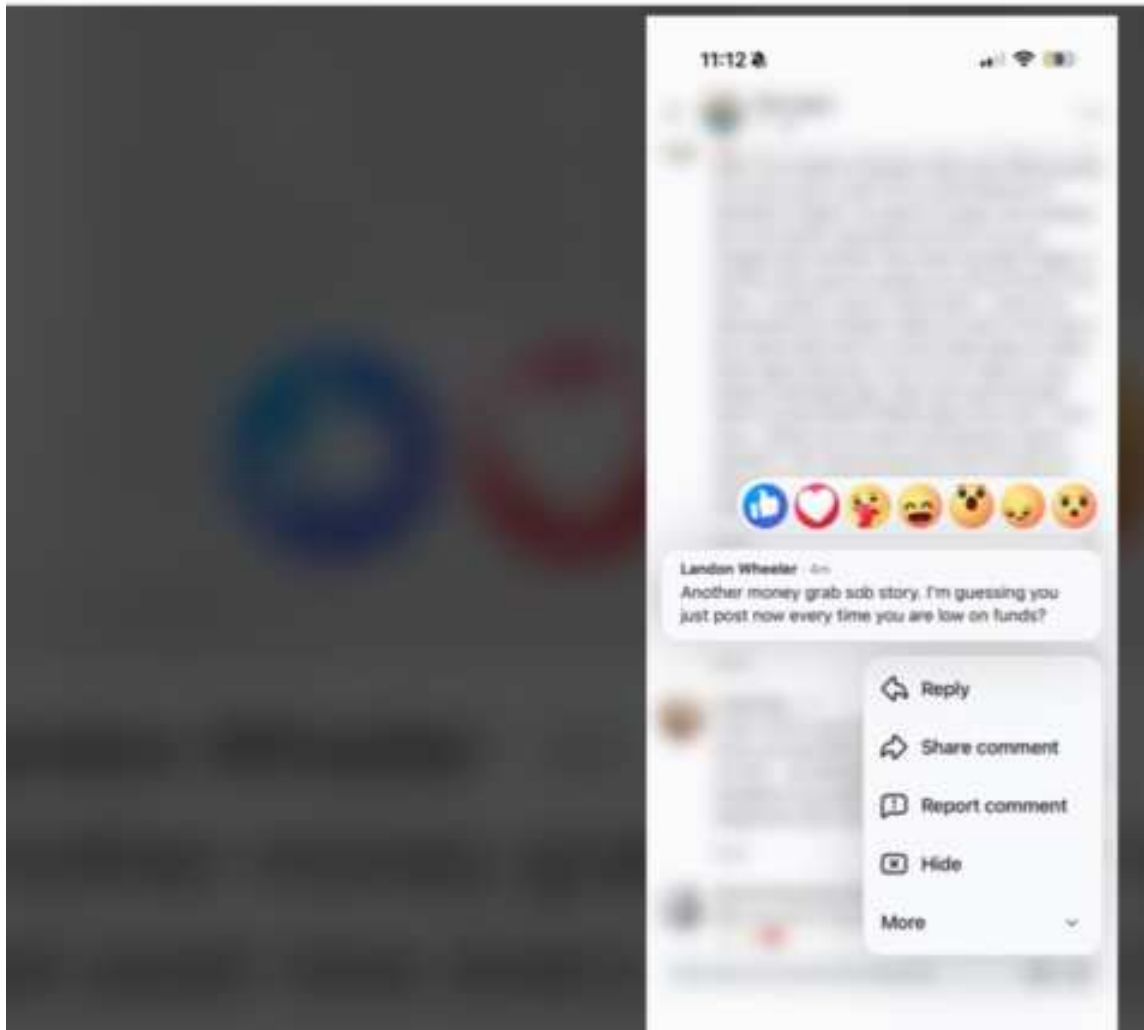
